### • Director's Report:

**Company Membership** – It was noted that there were 43 full members of the Association with the right to attend and vote at all general meetings. This represents only 50% of all active measurers. It was agreed that the Secretary would contact all measurers inviting them to apply for full membership.

**Measurers** – There are 86 active measurers currently listed in the AUKCM database. However, the database also lists 335 measurers, including those active, inactive, retired and trainees. It was agreed that the database should be reviewed and redesigned to make it easier to identify those in each category.

### Introduction:

The Association is a company limited by guarantee and the Objects of the Association are:

- a) to establish and maintain a system for the accurate measurement and certification of road race courses in the UK:
- b) to arrange and manage the recruitment, training, registration, grading and accreditation of road race course measurers in the UK;
- c) to regulate the delivery of an effective system of course measurement by accredited course measurers for the benefit of road race organisers and competitors in the UK;
- d) to foster and promote road race course measurement in the UK;
- e) to liaise with and advise the appropriate governing bodies, road race organisers and competitors.

### **Company Membership:**

As of 31 October 2022, the Company had 43 subscribing (full) members. Full members have all rights provided in the company articles, including voting rights at general meetings.

All other members are classed as Associates and will receive notices of meetings and general circulars but have no other rights of membership.

The AUKCM website lists 335 measurers but this includes trainees, retired measurers and other inactive members. During the coming year the opportunity will be taken to rationalise this register of measurers.

### Treasurers report AGM 2022

Once again, my thanks to Charmian Heaton for her help in preparing the accounts.

Our opening balance for this year is up to £7,452 compared to £6,080,as is income for the year, so overall income for the year is up from £4284 to £6437. This is from measurement of club races (157 races 21/22 compared to 95 20/21) and non-club races (396 21/22, 248 20/21).

So income is up and our balance at the bank is up. We have been offered £500 from ARC to cover expenses for this years AGM.

There is still a small number of unlicenced races obtaining measurement certificates, for which we do not get paid from the licencing bodies. I will continue to chase these up, but I know it is difficult for measurers to ensure that the races they are measuring are licenced.

Our main expenditure over the year is the maintenance fees for the 2 websites totalling £209/month. This year we have also spent £750 on new Jones counters, indicating that new trainees are coming through. We also spend £430/yr on liability insurance , also any expenses involved with the AGM.

Overall, we are in a healthy position, the current fees paid by the governing bodies covering our expenses, so I do not think there is any need to consider increasing the fees.
